"By Laws"

Article I – Meetings

Section I

The Municipal Alliance Committee for Prevention of Alcoholism and Drug Abuse, a Committee of the Borough of South River, New Jersey shall meet for the purpose of reducing alcoholism and drug abuse the third Wednesday of each month at 5:00 PM at 61 Main Street, Court/Council Chambers. In the event said Wednesday should fall on a legal holiday, then said regular meeting shall be held on that day following, not a holiday or weekend. During the months of November and December meetings will not be held.

Section II

During the month of January of each year, at the regularly scheduled meeting, there shall be the election of officers, adoption and signing of these "by laws" and annual appointments of contractual services.

Article II – Duties of Officers

Section I

It shall be the duty of the Chairperson to preside at all meetings of the board and to perform all duties usually pertaining to this office.

Section II

The Vice Chairperson shall perform all duties of the Chairperson in the absence or disability of the Chairperson.

Section III

The recording secretary shall keep minutes of all proceedings and record same. In the absence or disability of the recording secretary, the chairperson shall assign a member of the Committee to perform the duties of the recording secretary.

Article III – Membership

Section I

Members are required to attend all meetings unless being excused for sickness or other valid reason. Eight consecutive weeks or four consecutive regular meetings, whichever shall be of longer duration in a calendar year shall constitute automatic resignation. Unexcused absences shall be at the pleasure of the board and duly noted.

Section II

Each year, a copy of these “by laws” shall be distributed to each member for his or her use, and one copy, signed by all board members, shall be filed with the executive officer.

Section III

Should a regular position become available, an alternate member in sequence should fill that vacancy in an alternate position, a name shall be given from a recommendation of the Chairperson then passed along to the Mayor and Council for appointment.

In October of each year, the Chairperson will submit to the Mayor a list of current members who are up for reappointment and recommend to have these members reappointed. Should any member who is up for reappointment decide he/she does not want to be reappointed, the Chairperson will submit new name(s) to the Mayor to fill the vacant positions.

Article IV – Amendment

Section I

These “by laws” may be amended at any official meeting by a majority of the Committee members.

Article V – Meeting Procedures

Section I

Robert’s Rules of Order shall be the model on all matters not covered by the “by laws” of this board.

Article VI – Suspension of “By Laws”

Section I

These rules and regulation may be suspended in case of emergency by unanimous consent of all members present at an official meeting.

Article VIII – Public Comment

Section I

Public comment shall be afforded to all members of the general public at each regular meeting of the Municipal Alliance. Any member of the general public desiring to address the Municipal Alliance shall do so upon recognition of said speaker by the Chair. The speaker shall first identify herself/himself by name and address. The speaker shall be permitted to address the Municipal Alliance on any topic that is for the good and welfare of the general public. Comments shall be limited to ten (10) minutes per speaker per meeting. No questioning individual members of Board shall be permitted by any speaker. In the event a speaker wished to pose a question to any individual member, she/he shall address the question to the Chair, the time limitation imposed by this Rule may be waived or modified by a majority of the members present, upon motion duly made and seconded. No member of the public shall be allowed to poll the Board on any issue, whether said issue shall be put to an official vote.
