MINUTES

Monthly minutes for April 20, 2016, were submitted for approval and/or amendment. C. Deerson made a motion to approve the minutes and was seconded by P. Guindi. All were in favor.

OLD BUSINESS

Adam DeHanes is going to make sure we are able to get the dunk tank. Last year it cost us \$200. A. DeHanes is also going to make a flyer/registration form to send to vendors (no food vendors). There will be a \$25 fee. D. Nale is handling getting the flyer/registration form to the borough departments, committees, and organizations. It was decided that Municipal Alliance and the PBA/SOA will do the hot dogs (\$2), hamburgers (\$3), and sausage sandwiches (\$5) together and split the profits 50/50. C. Deerson will be making the sausage, peppers, & onions. The profits from the water (\$1), soda (\$1), chips (2 for \$1), Italian ice (\$3), and pretzels (\$3) will only go to Municipal Alliance. We aren't using the Italian ice guy that we used last year. D. Jones has gotten Stop & Shop to either donate or the most it will cost us is \$1 the Italian ice. We are going to rent an ice cream cart (\$125) and purchase dry ice. D. Jones will get a price for the dry ice. We are going to rent a pretzel warmer (\$65) and cook the pretzels on the grill. A. DeHanes is making the food tickets & menus. We are going to plan for 500 people for the food. D. Jones will contact DPW for them to hang NNO banners up.

Adam DeHanes will cancel the Italian ice guy and we will be doing the same thing with the Italian ice that was done on NNO. We will also be selling 50/50.
