- Power outage last Thursday – Will be meeting with representatives from PSE&G to discuss outage. There was a fire in East Brunswick, one line shut down and second line should have kicked in; temporary repairs were made; both lines are running now. Noted that South River has spent \$8 million in upgrading system and \$3 million in equipment. We want the same commitment from PSE&G. Two lines from East Brunswick are dedicated lines for South River, 25 megawatts on each line.

Appreciates patience of residents; there is nothing South River could have done; kudos to all safety personnel; will have options if not pleased with PSE&G and can pursue further with BPU and FERC.

- Electric rate study - had lengthy discussion at last meeting; disappointed some of the Council members did not accept that his written comments on the electric rate study be spread in full in the minutes; council comments is time to make statements on this important issue.
