



Fred,

I recently received an email from Brian Hyslop who was a former Class I Special Law Enforcement Officer with this department. Brian resigned from this position on June 22, 2012 because he had taken a job with the Greenville County Sheriff's Office in South Carolina for the position of Police Officer. He successfully attended and graduated the South Carolina Police Academy and started working in the Patrol Division with the department. Brian's plan was to complete his training and subsequently move his wife and young daughter to South Carolina until his wife received a big promotion with her current job. After careful thought, Brian and his wife have decided to stay in New Jersey where family is nearby and the community was better suited to raise their young daughter.

With Brian relocating back to New Jersey, he has asked to be reappointed to the position of Class I Special Law Enforcement Officer. I have spoken with a representative from the Police Training Commission who stated that Brian's certification was still valid and he would not need to attend a Special Law Enforcement Academy.


The ability to reappoint Brian Hyslop would be a great benefit to this Agency as well as the Borough. Brian's knowledge of this department and his experience would be an asset especially to the two (2) Specials that will be graduating the academy in May.

As you are aware, the cost of appointing a Special Law Enforcement Officer includes the attendance to the Police Academy as well as the equipment and any medical testing required prior to appointment. Brian's reappointment would be cost effective because there would be no need to send him to a Class I Police Academy and all his equipment including his uniforms are still in his possession.

Dear Mr. Carr:

Pursuant to your request, we have reviewed the Borough Public Works Yard with Mr. Adriano Soares to select a location for the proposed Truck Wash Pad. Enclosed, please find a plan showing the location we selected.

I have measured a Borough garbage truck which I believe is the longest vehicle that will be washed on the pad. It was approximately forty (40) feet in length and eight (8) feet in width. I recommend the pad be six (6) feet wider on each side to allow room for the person washing the vehicles. That translates into a pad that will be fifty-two (52) feet long and twenty (20) feet wide. There will be concrete curbing around the perimeter of the pad and a drainage inlet in the middle of the pad to collect the wash water. The inlet will drain into a grease trap which will connect to a local sanitary sewer line.

Given the urgent nature to construct this facility, as required by the NJDEP, we recommend the Borough allow us to approach S. Brothers, Contracting, who will be performing the Kamm Avenue – Section II Improvements, and request a price to construct the inlet, piping to the grease trap, install the grease trap, construct the concrete curbing and the concrete pad.

Base on a preliminary review of the required work, we estimate the project will cost about \$25,000.00. This is based on the condition the Borough Water/Sewer Department personnel will install the piping from the grease trap to the sanitary sewer system and will run a water service up to the pad to connect the power washer to. We discussed this matter during our field visit and all parties agreed to same.

We can provide the design and construction administration services for the work for a cost not to exceed \$4,850.00.






