RESOLUTION

WHEREAS, the Borough of South River duly advertised for the receipt of bids for the Borough of South River New Fire Headquarters; and

WHEREAS, in response to the invitation to bidders, fifteen (15) bids were received on July 23, 2015; and

WHEREAS, the bids have been reviewed by the Borough's Architect and it has been determined that D&K Construction Company Inc. submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$7,407,000.00, which sum includes a base bid of \$6,947,000.00 and \$460,000.00 for Alternate #1; and

WHEREAS, it is the desire of the governing body to award a contract for the Borough of South River New Fire Headquarters to D&K Construction Company, Inc., the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Borough of South River, County of Middlesex, State of New Jersey as follows:

1. That the governing body does hereby award a contract for Borough of South River New Fire Headquarters to D&K Construction Company, Inc., at \$7,407,000.00, which sum includes a base bid of \$6,947,000.00 and \$460,000.00 for Alternate #1
2. That the Mayor and Municipal Clerk are hereby authorized to execute a contract with D&K Construction Company, Inc., in accordance with the bid submitted by D&K Construction Company, Inc., and the bid specifications.

3. That the governing body specifically approves the bid specifications, designs and plans prepared in connection with the Borough of South River New Fire Headquarters.

4. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances, which constitute the availability of funds for this contract: C-06-15-010-101 and C-06-15-010-201.

5. That a certified copy of this resolution, together with a copy of the contract between the parties, shall be forwarded to the Chief Financial Officer, the Borough Architect, and D&K Construction Company, Inc.
