ORDINANCE 2015 -5

**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER,
COUNTY OF MIDDLESEX, STATE OF NEW JERSEY,
AMENDING THE BOROUGH CODE OF THE BOROUGH OF
SOUTH RIVER, SO AS TO AMEND CHAPTER 350,
ENTITLED "ZONING" SECTION 350-11 ENTITLED
"EXCEPTIONS AND PERMITTED MODIFICATIONS TO
BULK STANDARDS"**

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

SECTION 1. Chapter 350 of the Borough Code of the Borough of South River, entitled "Zoning" is hereby amended so as to amend Section 350-11 "Exceptions And Permitted Modifications to Bulk Standards" so as to delete Section 350-11(B) and; therefore, read in its entirety as follows:

§ 363-11. EXCEPTIONS AND PERMITTED MODIFICATIONS TO BULK STANDARDS.

- A. Exceptions to height limitations.
- (1) The provisions of this chapter with regard to height shall not apply to church spires, steeples, belfries, clock towers, noncommercial radio towers, flagpoles, chimney stacks, skylights, scenery lofts, antennas, water tanks, fire or parapet walls or roof structures for the housing of elevators, stairways, ventilating fans, air-conditioning equipment or similar equipment and structures, provided that such features shall be erected only to such height as is necessary to accomplish the purpose they are to serve.
 - (2) No part of any structure erected pursuant to Subsection A(1) to a height in excess of the height limit for the zone in which it is situated shall:
 - (a) Have a lot coverage in excess of 10% of the lot area.
 - (b) Be used for residence or tenancy purposes.
 - (c) Have any sign, nameplate, display or advertising device of any kind whatsoever inscribed or attached to that part of the structure which exceeds the height limitation.
- B. (deleted.)

- C. Exceptions to yard requirements.
- (1) Where a lot is situated between two lots, each of which is developed with a main building which projects beyond the established front building line as required by this chapter and has been so maintained since the enactment of this chapter, the minimum front yard requirement of such lot may be the average alignment of the front yards of said existing buildings.
- D. Exceptions to maximize solar gain. In order to promote the conservation of energy, variations in the front, side and rear yard and area requirements of this chapter may be permitted, provided that the purpose of such variations is to orient buildings so as to permit said buildings to maximize solar gain and secure the full benefit of prevailing winds.

SECTION 2. After introduction of this ordinance, the Borough Clerk shall send a copy of this ordinance to the Borough Land Use Board for its review and comment. The Borough Clerk shall also send copies of this ordinance to all adjoining municipalities pursuant to N.J.S.A. 40:55D-15 and to the Middlesex County Planning Board pursuant to N.J.S.A. 40:55D-16.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law and filing of the adopted ordinance with the Middlesex County Planning Board.

SECTION 6. After adoption of this ordinance on second reading, the Borough Clerk shall file a certified copy of this ordinance with the Middlesex County Planning Board.

ORDINANCE 2015-6

**AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER,
COUNTY OF MIDDLESEX, STATE OF NEW JERSEY,
AMENDING THE BOROUGH CODE OF THE BOROUGH OF
SOUTH RIVER, SO AS TO AMEND CHAPTER 363,
ENTITLED "FOOD AND BEVERAGE SERVICE" ARTICLE
IV ENTITLED "MOBILE RETAIL FOOD
ESTABLISHMENTS"**

BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, as follows:

SECTION 1. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-11. "Definitions" so as to read in its entirety as follows:

§ 363-11. DEFINITIONS.

MOBILE RETAIL FOOD ESTABLISHMENT

A vehicle, normally a van, truck, towed trailer or push cart, from which food and beverages are sold

OWNER

Any person, firm or corporation who owns a mobile retail food establishment

OPERATOR

Any person who operates a Mobile Retail Food Establishment which services are made available to the general public

MOBILE RETAIL FOOD ESTABLISHMENT SALES EMPLOYEE

Any employee who works in or with the Mobile Retail Food Establishment from which services are available to the general public and who has direct contact with the general public providing the aforementioned services

MOBILE RETAIL FOOD ESTABLISHMENT ONE DAY EVENT PERMIT

A twenty-four (24) hour permit provided to any Mobile Retail Food Establishment which services are made available to the public in a stationary location in connection with an event held within the Borough.

SECTION 2. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-13.

"Application for License" so as to read in its entirety as follows:

§ 363-13. APPLICATION FOR LICENSE.

- A. Applications for all licenses and permits required by this article shall be made in writing to the Borough Clerk. Each application shall contain the following information in the suggested format and include the application and permit fees required by § 363-25 hereinafter:
1. The name under which business is to be conducted;
 2. The name of the applicant/owner. If a corporation, give the names and addresses of the president and secretary. If a partnership, give the names and addresses of all partners;
 3. The name and address of all operators and mobile food establishment employees as defined in § 363-11;
 4. The present residence address and the address of the business, if different;
 5. The location or route within the Borough where the business is to be conducted;
 6. The addresses and municipalities in which the business has operated for the past five years;
 7. The nature of the business;
 8. The residence of the applicant during the past five years (if an individual);
 9. Whether the applicant has ever had a license to conduct the business herein described denied or revoked, except as noted;
 10. The business telephone number of the applicant;
 11. The name and address of the attorney, if applicable;
 12. The name and the address of the registered agent if the applicant is a corporation or limited-liability company; and

13. New Jersey Motor Vehicle Registration Plate number of the vehicle sought to be licensed.
 14. A certification that the applicant makes the statements above to induce the Borough of South River to issue the license herein applied for and agrees to comply with all laws and ordinances of the Borough and State of new Jersey applicable to the subject matter thereof.
- B. All owners, operators and Mobile Retail Food Establishment Sales employees, as defined in § 363-11, shall obtain a criminal background check at a private agency approved by the Borough and shall submit the same. The results of the criminal background check shall be forwarded by the approved agency directly to the Borough Clerk. The cost of the criminal background check shall be borne by the applicant. All operators shall also obtain a driver's abstract and shall submit the same to the Borough if the mobile retail establishment is consider a motor vehicle. All Mobile Retail Food Establishment One Day Event permits, as defined in § 363-11, are exempt from this requirement.
- (1) For the duration of the license, the owner has a continuing duty to provide the Borough with criminal background checks and driver's abstracts for any new operators and Mobile Retail Food Sales Establishment employees engaged or hired after the issuance of this license.
 - (2) The Borough must individually approve, pursuant to §363-17, each new operator and Mobile Retail Food Sales Establishment employee prior to the employee operating or selling within the Borough.

SECTION 3. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-17.

"Investigations and Inspections" so as to read in its entirety as follows:

§ 363-17. INVESTIGATIONS AND INSPECTIONS.

- A. Upon receipt of an application for a license or permit, the Borough Clerk shall refer such application to the following departments for the purpose of making an investigation or inspection, and said departments shall make a report thereon, favorably or otherwise, within seven business days after receiving the application or a copy thereof:
1. Health Department (with respect to such licenses in connection with the care and handling of food and the prevention of nuisances and spread of disease and the requirements of this article).

2. Zoning Officer (to determine solely whether the proposed business conforms to the zone in which the property is located and the requirements of this article). All Mobile Retail Food Establishment One Day Event permits, as defined in § 363-11, are exempt from this requirement.
 3. Fire Prevention Department (to determine whether or not the vehicle to be utilized under the requirements of this article complies with the fire safety codes and the requirements of this article).
- B. Upon receipt of the criminal background check and driver's abstract, the Borough Clerk shall forward the complete application, including the background investigation, to be reviewed by the Chief of Police who shall cause such investigation of the criminal background and business and moral character to be made as they deem necessary for the protection of the public good. Said investigation, prior to the issuance of a license hereunder, shall be mandatory. If the result of said investigation is that the application is satisfactory, same shall be approved by the Chief of Police. If as a result of such investigation the applicant's background reveals a prior history involving crimes of moral turpitude within the past 10 years or if the operator's driving records, character or business responsibility is found to be unsatisfactory, the application may be recommended to be denied. If the application is recommended to be denied, the reasons for said denial must be indicated in writing by the Chief. All Mobile Retail Food Establishment One Day Event permits, as defined in § 363-11, are exempt from this requirement.
- C. In the event that any department's investigation or inspection indicates some unfavorable comment, that department shall set forth specifically the facts for such comment in writing.

SECTION 4. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-21. "Expiration of Fees; Termination of License" so as to read in its entirety as follows:

§ 363-21. EXPIRATION OF FEES; TERMINATION OF LICENSE.

- A. The fees for licenses for mobile retail food establishments shall be effective for the period January 1 to December 31 of any given year or for any part thereof and shall be renewed annually.
- B. All licenses shall terminate when the licensee ceases to operate within the Borough of South River.

- C. All Mobile Retail Food Establishment One Day Event permits, as defined in § 363-11, shall terminate as provided in the permit; however, no one day permit shall be effective for more than twenty-four (24) hours.

SECTION 5. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-22. "Change of Location; transfer of license" so as to read in its entirety as follows:

§ 363-22. CHANGE OF LOCATION; TRANSFER OF LICENSE.

- A. The location of any licensed mobile retail food establishment may be changed, or a license may be transferred to another cart or vehicle, provided that 10 days' notice thereof is given to the Borough Clerk, approval is granted by the governing body, the requirements of all Borough ordinances are complied with and payment of a license transfer fee is made in accordance with this article and Chapter 155 of this Code.
- B. This provision shall not be applicable to Mobile Retail Food Establishment One Day Event permits, as defined in § 363-11. The Mobile Retail Food Establishment licensed under an One Day Event permit shall remain stationary in the location provided for in the original application while serving the public and shall not change its location to serve the public in any other location within the Borough.

SECTION 6. Chapter 363 of the Borough Code of the Borough of South River, entitled "Food and Beverage Service" is hereby amended so as to amend Section 363-24. "Posting of License" so as to read in its entirety as follows:

§ 363-24. POSTING OF LICENSE AND DECAL.

- A. Licenses issued under this article shall be posted at the mobile establishment in a conspicuous place. Said license shall remain posted for the duration of the licensing year when issued and so long as the licensed business is in operation.
- B. A Borough issued decal shall be displayed in a conspicuous place on the outside of the mobile retail establishment. If the establishment is a motor vehicle, the decal shall be placed on the rear of the vehicle. Said decal shall remain posted for the duration of the licensing year and so long as the licensed business is in operation. This section is inapplicable to All One Day Event Mobile Retail Food Establishment permits as defined in § 363-11.

SECTION 7. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 8. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 9. This ordinance shall take effect after second reading and publication as required by law

ORDINANCE 2015-7

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AUTHORIZING AN AMENDMENT EXTENDING THE CURRENT TAX ABATEMENT AGREEMENT WITH NATIONAL CHURCH RESIDENCES OF SOUTH RIVER, NEW JERSEY THROUGH 2052.

WHEREAS, the Borough of South River is a party to a Tax Abatement Agreement with National Church Residences of South River, New Jersey, a non-profit corporation of the State of Ohio and authorized to do business in New Jersey, and owner of the housing facility known as Willett Manor, located at 340 Whitehead Avenue, South River, NJ 08882, dated September 6, 1990; and

WHEREAS, the current Tax Abatement Agreement between the Borough of South River and National Church Residences for the property at Willett Manor shall expire January 2042; and

WHEREAS, Willett Manor is committed to continue providing safe, clean and affordable housing for the elderly and disabled into the future which is a benefit to the community; and

WHEREAS, National Church Residences of South River, N.J., is currently seeking to refinance its existing U.S. Housing and Urban Development (HUD) loan to reduce its annual debt service and provide funds to complete both critical and non-critical repairs to ensure that Willett Manor is a well maintained, safe and viable housing project into the future; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has expressed its strong support to the request to extend Willett Manor's existing tax abatement as it will further HUD's mission to create strong, sustainable, inclusive communities and quality affordable homes; and

WHEREAS, the pending HUD 223(f) refinance loan shall be for a period not to exceed thirty-five (35) years and HUD requires National Church Residences to renew the current HAP contract for an initial period of 20 years and execute a Preservation Agreement committing the property to an extension of the HAP contract upon its expiration; and

WHEREAS, the Borough of South River has the authority to extend the Tax Abatement Agreement to run co-terminus with the HUD 223(f) refinance loan pursuant to N.J.S.A. 40A:20-13.1.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of South River, County of Middlesex, and State of New Jersey, that it does hereby authorize the Mayor to execute, on behalf of the Borough of South River, a Tax Abatement Agreement Extension with National Church Residences of South River, N.J., in form substantially similar to that attached hereto and made a part hereof, through 2052, commencing and effective upon National Church Residences of South River, N.J., refinancing its mortgage loan with HUD.

BE IT FURTHER ORDAINED that any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

This ordinance shall take effect after second reading and publication as required by law.

**TAX ABATEMENT AGREEMENT EXTENSION BY AND BETWEEN NATIONAL
CHURCH RESIDENCES OF SOUTH RIVER, N.J. AND THE BOROUGH OF
SOUTH RIVER FOR THE
WILLETT MANOR LOCATED AT
340 WHITEHEAD AVENUE, SOUTH RIVER, NJ
(BLOCK 356, LOT 1)**

This Tax Abatement Agreement Extension made this ____ day of _____, 2015 between National Church Residences of South River, N.J., a non-profit corporation of the State of Ohio (the "Corporation") and authorized to do business in New Jersey, with a housing facility known as Willett Manor, located at 340 Whitehead Avenue, South River, New Jersey 08882 (the "Project"), and the BOROUGH OF SOUTH RIVER, a municipal corporation, in the County of Middlesex and State of New Jersey (the "Municipality").

WHEREAS, the Municipality and the Corporation are parties to a Tax Abatement Agreement on the Project dated September 6, 1990 which is still in force and effect; and

WHEREAS, it is the intention of the Municipality to extend the Tax Abatement Agreement through December 31, 2052 in accordance with N.J.S.A. 40A:20-5.1 and N.J.S.A. 40A:20-13.1

NOW, THEREFORE, in consideration of the mutual covenants herein contained and for good and valuable consideration, it is mutually agreed as follows:

1. This Agreement is made pursuant to the authority of *N.J.S.A. 40A:20-1, et seq.*, the "Long Term Tax Exemption Law" and specifically N.J.S.A. 40A:20-5.1 and N.J.S.A. 40A:20-13.1, and Borough Council Resolution 1988-297 dated July 27, 1988 and Ordinance No. XXX of 2015, the terms of which are incorporated herein by reference.

2. The term of the Tax Abatement Agreement is extended for a term uninterrupted through December 31, 2052.

3. The address for notice to the Corporation shall be 2335 North Bank Drive, Attn RET Dept/ HAC, Columbus, OH 43220, or to such other address as the Corporation may hereafter designate in writing.

4. Should the Corporation's request for an extension be granted, then the Corporation shall be responsible for the Borough's attorney's fees and costs incurred by the Borough in connection with the Corporation's request for the 2015 extension. Payment shall be made by the Corporation to the Borough within thirty (30) days of being provided an invoice requesting payment.

5. In all other respects, all of the terms and conditions of the Tax Abatement Agreement dated September 6, 1990, a copy of which is attached hereto and made a part hereof, are hereby ratified and confirmed by the parties.

SECTION 2. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause, or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION 3. All Ordinances or parts of Ordinances inconsistent with or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This Ordinance shall take effect after final passage, adoption, and publication according to law.

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AUTHORIZING THE ACCEPTANCE OF AN EASEMENT RUNNING THROUGH BLOCK 284 LOTS 12 & 21

WHEREAS, Antonio and Rosa Soares are the owners of property within the Borough of South River known as Block 284, Lot 12 & 21; and

WHEREAS, Antonio and Rosa Soares wish to convey to the Borough of South River an easement consisting of approximately 15 foot wide land strip along a portion of property known as Block 284, Lots 12 and 21 on the Tax Map of the Borough of South River as more fully described in Schedule A attached hereto and made a part hereof; and

WHEREAS, the acquisition of easements in real property is authorized by N.J.S.A. 40A:12-5(a)(1).

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of South River, County of Middlesex and State of New Jersey, as follows:

SECTION 1. The Borough Council hereby authorizes and approves the acquisition for the purchase price of \$1.00 from Antonio and Rosa Soares a perpetual easement consisting of approximately 15-foot wide land strip along a portion of property known as Block 284, Lot 12 & 21 on the Tax Map of the Borough of South River. The easement is attached hereto and incorporated herein as Schedule A.

SECTION 2. The Mayor and Borough Clerk are hereby authorized and directed to execute any and all such documents providing for the Borough's acquisition of interest in the Property and to undertake any and all such acts as may be necessary to effectuate the terms hereof, subject to the Borough Attorney's approval of the form and substance of said documents.

SECTION 3. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

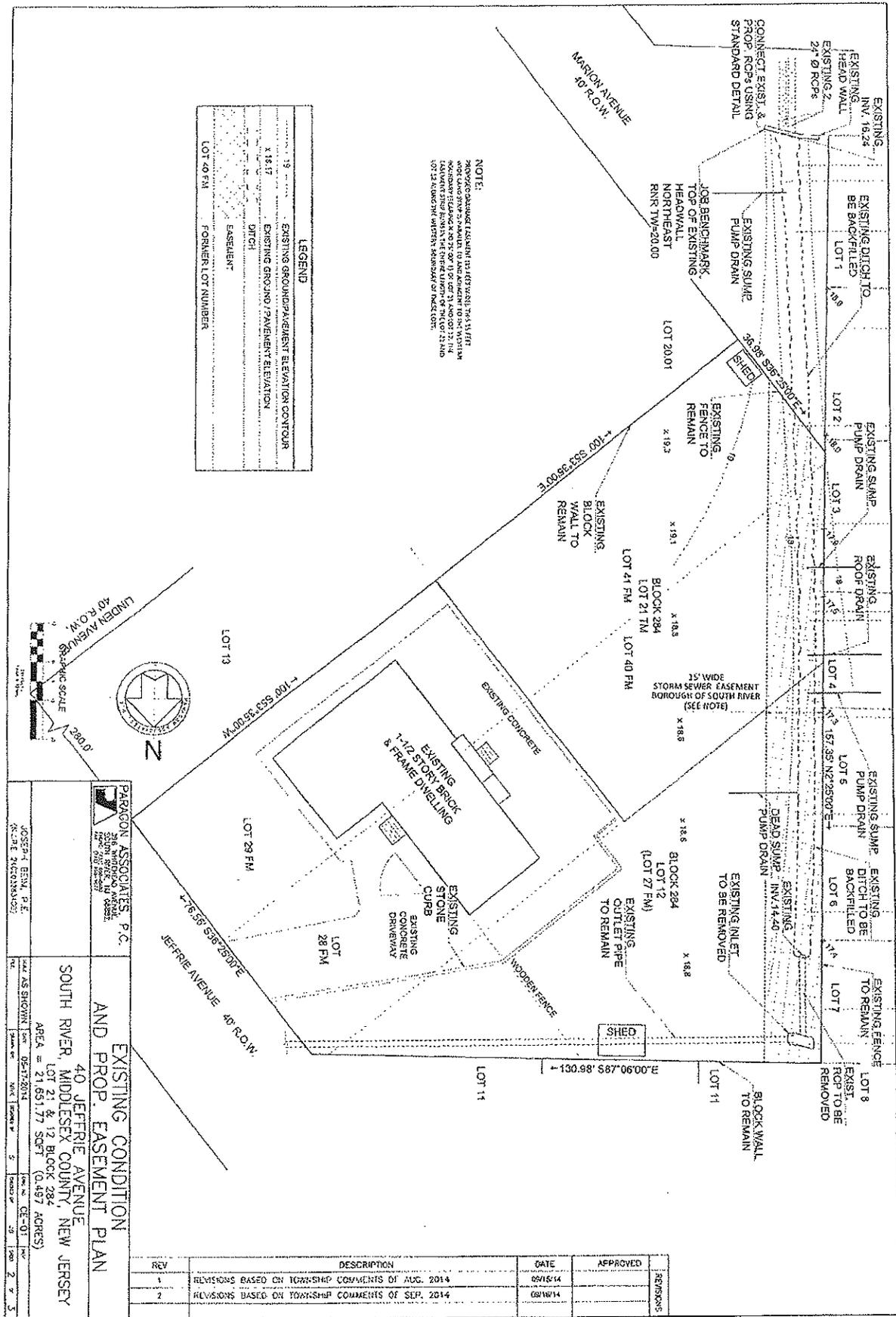

WHEREAS, Sergeant Joseph Grekoski is eligible to resign as a Police Sergeant from the Borough of South River, retire and receive a pension from the Police and Firemen's Retirement System ("PFRS") effective January 1, 2016 and

WHEREAS, Sergeant Grekoski has indicated his intent to resign from the South River Police Department and submit retirement papers to the PFRS effective January 1, 2016, and

WHEREAS, prior to his resignation and retirement Sergeant Grekoski will take sick leave to address a health issue, and

WHEREAS, Sergeant Grekoski is a member of SOA Local 62 and entitled to certain benefits thereto, and

WHEREAS, the Borough of South River and Sergeant Joseph Grekoski desire to express the terms of Sergeant Grekoski's sick leave, resignation from the Borough and retirement from the pension system;

THEREFORE, the Borough and Sergeant Grekoski hereby agree as follows:

1. Beginning on March 20, 2015 Sergeant Grekoski will go on sick leave and, given the expected duration of his recovery, he will utilize 110 accrued paid sick days (882 hours) during his absence. During his sick leave Sergeant Grekoski's Borough-paid health benefits shall continue.

2. Following exhaustion of his 110 paid sick days, in lieu of returning to work, Sergeant Grekoski will commence utilizing contractual benefits time and his terminal leave benefits, as delineated in paragraph 3 below (hereinafter referred to a "leave time"). Sergeant Grekoski shall resign from the Borough and retire from PFRS effective January 1, 2016.

3. During his leave time, Sergeant Grekoski shall remain in a pay status by utilizing 35 vacation days (280 hours), 10 days of personal time (80 hours) and 54 days of terminal leave (432 hours) pay consistent with the Borough Code, which shall maintain him in a pay status through December 31, 2015. During this leave time, Sergeant Grekoski's Borough-paid health benefits shall continue.
4. Any remaining vacation or personal days owed to Sergeant Grekoski after December 31, 2015 will be paid to Sergeant Grekoski via a payroll check issued January 2016.
5. In addition to the use of paid time off as outlined in paragraph 3 above, following his effective retirement date, Sergeant Grekoski shall be paid \$30,000.00 for his accrued but unused sick days, which represents 513.5 hours, in accordance with Article XIX.U of the SOA contract, which shall be paid in three (3) installments of \$10,000.00 each. These installment payments shall be paid with the second payroll in January 2016, January 2017 and January 2018.
6. In addition, Sergeant Grekoski shall also be paid for his accrued but unused XTO/Compensation Time. Sergeant Grekoski will be paid for 150.6 hours for a total payment of \$8,798.05, which shall be paid by payroll check on the second payroll date in January 2016.
7. The Borough will provide Sergeant Grekoski with retiree medical benefits (paid family health and prescription), consistent with the SOA contract under which he retired. If in the future, the State of New Jersey mandates that retirees in the Police and Firemen's Retirement System must contribute to their retiree health benefits provided by municipal employers, Sgt. Grekoski agrees that he will contribute any required amount.
8. In the event that Sergeant Grekoski is required to testify or appear in any court of law arising out of and directly related to his duties as a South River police officer on or

after his effective retirement date (January 1, 2016), in such a circumstance, Sergeant Grekoski will be compensated at his hourly rate of \$58.42 for all hours spent testifying or appearing in court.
