



The above referenced project has been completed. Accordingly, enclosed please find a completed Voucher and Payment Estimate No. 5 and Final Close-out Change Order for the work performed by Forest Electric Corporation for the above referenced project from September 1, 2015 to October 20, 2015.

Please note, the Final Close-out Change Order reflects the final contract quantities and supplemental items including reductions and increases in same due to actual field conditions encountered. The Close-out Change Order calls for an overall decrease in the original contract in the amount of \$25,000. Accordingly, we recommend acceptance of the work, approval of the Final Close-out Change Order and Payment Estimate No. 5 for work on the above referenced project and payment in the amount of \$20,324.12 to Forest Electric Corporation, subject to the posting of a one year maintenance bond in the amount of \$134,055.90.

We have enclosed a copy of September Requisition No. 5, submitted to us by the Contractor, as a supporting document to the necessary Certified Payroll Records and Project Manning Reports that the Contractor will submit to the Borough Clerk.
